5. **Confirmation of Voting Entitlements**

Neven pointed out that the hardest and most difficult job for OSF is to maintain effective communication with Member Countries. OSF & Member Countries need to continue to grow squash in the South Pacific and get value for money from the funds accumulated over the past 4 years. Our major goals need to be increasing player numbers, improving the standard of current facilities and construction of new facilities.

Many Federations try to promote the game at the wrong end and concentrate on competitions and elite players. We need to get young people (7 – 19 yrs) to play squash, get on a court and enjoy themselves. They are the future of our game. School programs can be successful in bringing in new players. Organisations need to change the way they think and promote our sport, and try to offer young people of today what they want, eg use of technology.

Being his last term as President, Neven thanked the support of the Members and the OSF Officers over the past 4 years.

Record of Discussions from the 2016 Workshop

held in conjunction with the General Meeting in Auckland on 19<sup>th</sup> November 2016

## **World Squash Federation Update**

The 2016 WSF Annual General Meeting was held recently in Hong Kong. Oceania was represented by Neven, with Jim representing New Zealand and Richard and David Mandell from Australia. The incoming WSF Board are all new with no ongoing officers from the previous Board. Sarah Fitz-Gerald from Australia was elected as Vice President along with Pablo Serna (Columbia), Gar Holohan (Ireland), Huang Ying How (Malaysia) and new President Jacques Fontaine (France). There is a high expectation from members for change and there will be challenges for the new Board. Olympic Bid is still high on the Agenda and with Paris lobbying for the 2024 Olympics squash may have a chance for inclusion if France are successful.

## **Role & Function of OSF**

OSF's role within Oceania is to promote and try to grow the game of squash with assistance from Member Countries. We need to work together to develop not only our players but also our coaches and referees.

## **Communication**

Communication is vital in the Oceania Region and Members are reminded that they need to communicate more effectively with OSF. We need more articles to upload to the OSF website especially posters for upcoming events, local newspaper articles referencing squash and results of Championships held. It is recognised that many of our Members have Facebook pages and upload information onto these – this information could also be sent to the OSF webpage. A link to Facebook pages could be included on the website for broader distribution.

## **Oceania Membership**

All countries/territories within the Region that have squash facilities are Members of the Federation and there is little likelihood that we will increase Membership for some years. A statistical comparison between 2011 & 2016 noted that over the past 5 years we have lost overall 7 squash centres across the region and 26% of our available singles courts.

## **Oceania Championships**

Tahiti will host the 2017 Oceania Championships in Papeete in September 2017. Arrangements are well underway and a formal invitation from OSF will be sent to each Member Country early in 2017. OSF is working closely with Tahiti to ensure that all information relating to the event is forwarded to Members, including confirmed dates, accommodation arrangements, transport, flight arrangements, proposed functions and updated Championships Rules & Playing Arrangements.

Early in 2017 Member Countries need to make a decision as to whether they intend to send a team as the event cannot go ahead without some commitment from Members. New Caledonia and Samoa have already indicated that they will be sending teams.

Member Countries are encouraged to start negotiations with potential sponsors and government officials to attempt to source funding to send teams. If there is any way the OSF can assist Members in securing financial support they are encouraged to contact the Executive Officer for assistance.

As the Championships will be a stand-alone event (ie not associated with the Pacific Games or Mini Games) until at least 2025 and not bound by Pacific Games rules the Rules & Playing Arrangements will be amended to meet our needs. Further consideration for players eligible to represent a country but are unable to play in their own country due to lack of facilities (eg Tokelau) will be explored. Australia and New Zealand may be invited to send teams if a minimum number of Member Countries are not met. OSF will work closely with Australia & NZ to set an applicable player standard to make the event competitive for smaller Island Nations if they are invited to compete.

**2019 Oceania Championships** – Samoa has expressed interest in hosting the Championships in 2019. OSF will work with Samoa to come to a formal agreement for 2019.

### **Oceania Junior Championships**

Scheduled to be held at the Henderson Squash Centre in Auckland from 14<sup>th</sup> to 17<sup>th</sup> April 2017. Entry details can be sourced through the Oceania Website on the Event Calendar.

Proposed dates from Australia for the 2018 OJC were considered too close to Xmas/New Year. Executive Officer to work with Australia to agree on more suitable dates.

### **Development Issues**

#### Australia

Squash Australia outlined several ways they may be able to assist with coaching, refereeing and schools programs. A proposed WSF Coach Tutor Training Course and WSF Coaching Course to be held Townsville in March 2017 was offered as a possible resource. WSF have confirmed that training Programs are currently only published in English. New Caledonia & Tahiti would need resources translated into French. Samoa would be interested in a coach going into Samoa rather than sending someone to Townsville.

Australia outlined an Australian Department of Foreign Affairs & Trade Partnership Program that may be of benefit to smaller Member Nations. Further details to be sourced and distributed as soon as possible.

Schools Programs are delivered through Australia's SquashOz program. This program and resources are available for other Member Countries to utilise.

Referee program is an online program and available also. OSF currently use Australia's referee system to accredit at Oceania specific levels.

New Zealand have similar resources available.

#### Coaching

OSF is looking for a suitable candidate to be appointed as the Oceania Regional Course Manger for the WSF Coach Education Program. New Board to consider.

### OSF Representation on WSF Committees

OSF needs to review how, and for what period, persons are appointed to represent Oceania on WSF Committee. All current OSF representatives will be advised that their tenure as a representative for OSF will cease as of 1<sup>st</sup> December. New appointments or re-appointments to these positions will be considered in the new year.

### 2017 General Meeting

Officers need to consider the best time to hold the meeting so we can potentially increase attendance. It appears that NZ may be the best option as all countries have direct flights (except PNG).

It is anticipated that WSF will announce their AGM date early in 2017. Several events have already been scheduled in late October/early November
